\$270,000 Awarded At BCF's Annual Celebration

On October 9, the Grand Upton Hall at Lake Michigan College was buzzing with energy, laughter and a whole lot of community pride as Berrien Community Foundation hosted its **73rd Annual Meeting & Celebration** — and let's just say, it was a homecoming to remember!

With a theme that celebrated coming together and giving back, BCF awarded \$270,000 in grants to local organizations. From playgrounds to prom nights, the evening was a joyful reflection of the teamwork and heart that fuels our community.

This year, BCF helped bring inclusive play to more neighborhoods with upgrades to Silver Beach County Park Playground and Kaleidoscope Playground at Kiwanis Park, plus exciting plans for Euclid Avenue Park in Benton Heights.

We also celebrated our first-ever Program Related Investments to Kingdom Business via Emerge Innovation Hub and Amy's Kitchen in Watervliet.

Major highlights of the night were awarding the Alamar Nonprofit Sustainability Grant, Carolyn's Kids Grants, Stephen E. Upton Love Your Community Grant, Golden Acorn Volunteer and Excellence Awards.

Ruth Kremer


Ruth Kremer was crowned with the **Golden Acorn Volunteer** Award; she is a powerhouse volunteer with the nonprofit, United Through Motherhood. She launched a diaper bank to address diaper insufficiency — a hidden crisis that prevents parents from accessing daycare, work or school. Always ready to help, Ruth brings heart, energy and teamwork to every project and turns any challenge into a touchdown! Along with the recognition, Kremer was awarded a \$1,000 grant to direct to the nonprofit organization of her choice.

Fund A Senior Care Kit!

Just \$20 sends a Senior Care Kit to a vulnerable, homebound senior citizen in Berrien County. This year, we will send out more than 1,100! One in 10 Berrien County seniors are living below the poverty level and, when out-of-pocket medical costs are factored in, that statistic turns into 1 in 7. To help bring some financial relief, we provide basic hygiene and care items in the form of these kits. We do also add some fun things like adult puzzle books and candy!

Every year, we hear from seniors expressing their gratitude to us and to everyone who has contributed to this project. Some tell us they wait to unwrap their kit until Christmas morning as it's the only present they receive.

'Food Is Health' Brings Healthy Foods Into Homes

The Southwest Michigan Food is Health **Collaborative** is a coordinated initiative to improve access to quality, fresh foods to neighbors in need. The effort sources food from local growers to improve people's health and address the root causes of chronic disease. BCF, the Frederick S. Upton Foundation and Corewell Health Foundation are investing in the infrastructure of the project.

The Nutrition Exchange of Southwest Michigan led by Meals on Wheels of Southwest Michigan and funded by a \$200,000 grant from the Cook Plant Foundation – is a resulting pilot project to address food insecurity while supporting local agriculture,

and food pantries and food distribution sites around Berrien County.

Another pilot initiative, **Meat The Need** gave local businesses and individuals a chance to make a big impact by donating swine and steers purchased at the Berrien County Youth Fair livestock auction. Thanks to their generosity, almost 3,000 pounds of ground beef and pork were processed through a grant from BCF and distributed to food pantries throughout Berrien County.

Want to help? A donation to the Food for Good Fund at BCF will help continue these efforts.


T.E.A.M. Bulletin Teens Exhibiting Able Minds

Philanthropy Corner

6 Tips For Your Year-End Game Plan

With only a few months left in 2025, it is important to evaluate your philanthropy sooner rather than later. Recently-passed tax laws may throw a curveball into the financial planning strategies you've set in motion with your advisors.

Here are six tips to help you and your attorney, CPA and financial advisor evaluate whether adjustments to your charitable plan might be in order. Of course, the team at the BCF would be honored to join your charitable giving conversation. There are so many ways we can help!

- Review the new estate tax exemption: The 2025 exemption was raised to \$13.99M (single) and \$27.98M (married), increasing again in 2026.
- 2 Stay proactive: Even with favorable laws, future legislation may change so keep your charitable plans flexible. Continue to talk with us and your advisors about your charitable giving plans so you are ready to make adjustments when the laws change again.
- Don't undo your generosity: If you increased charitable bequests due to anticipated tax changes, consider retaining the larger bequest to your fund at BCF. You'll be doing a lot of good!
- Maximize 2025 deductions: Itemizers can benefit from "bunching" donations into 2025 before new limits kick in next year.
- Use smart giving tools: Gifts of appreciated stock and IRA beneficiary designations remain highly tax-efficient.
- Explore QCDs if 70½+: You can donate up to \$108,000 tax-free from your IRA to qualified charities in 2025.
